CONSENT AND RELEASE

1. By signing this consent and release letter (“Consent and Release”) the undersigned (“I”, “me”, “my”, “we” or “our” and such designations shall include my/our estate(s) or any representative(s) acting on my/our behalf in the event of my/our incapacity or death), as parent/guardian for the participant at the “Tech Education Summit” organised by the Government of Bermuda, represented by The Cabinet Office, Economic Development Department (the “Government”) hereby consent and grant the Government, for an indefinite term, the authority to photograph or record the participant and to use the participant’s likeness, image, sound, recording, performance or any portion thereof (together, the “Performance”) or name throughout the world in any medium, including, but not limited to any reproduction, recording, portrayal, publication, copying, modification, performance, distribution or display of my name, image, likeness, voice, speech and other personal characteristics in any manner, form, format or media whatsoever (“Media”) for any purpose relating in any way to the publication, display, advertising, marketing or promotion of whatsoever purpose that the Government may choose. I/we also acknowledge and agree that I/we will not have the right to review the Media or Performance before publication or distribution.

2. I/we acknowledge and consent that the Government may store copies of the Performance or Media in any location for any purpose and the Government may also store my/our or the participants contact details on a database in case the Government needs to contact me/us or the participant.

3. I/we hereby forever release and discharge and shall indemnify and keep the Government indemnified, to the fullest extent permitted by law, from all manner of causes of action (including actions based on privacy), demands, claims, liabilities, debts, expenses (including legal fees and expenses), penalties, fines and any other losses, which I/we or the participant and each of my/our: heirs; executors; administrators; assigns or representatives can, shall or may have against the Government at any time as a result of any act or matter arising out of or in connection with this Consent and Release.

4. I/we agree that the Performance and Media, and any drafts, electronic files, partial recordings or images and negatives thereof, shall constitute the Government’s sole property.

5. I/we understand that by attending the “Tech Education Summit”, the participant will be exposed to, among other topics, sessions regarding technology education and awareness.

6. This Consent and Release shall be effective and binding upon myself/us, the participant, executors, administrators and representatives in the event of my/our or the participant’s death or incapacity.
